

**AMENDED PETITION FOR THE EXCLUSION OF TERRITORY / DE-ANNEXATION  
OF LAND WITHIN THE TOWN OF BUFFALO CHIP, SD**

I, Daymon Woodruff, sole general partner of BC Realty, LLLP, being duly authorized to so act on behalf of BC Realty, LLLP, owner of record of the subject property described below in the Town of Buffalo Chip, South Dakota, do hereby petition the Buffalo Chip Town Board to exclude and/or de-annex a portion of said land pursuant to SDCL 9-4 of the South Dakota Codified Laws, according to the following:

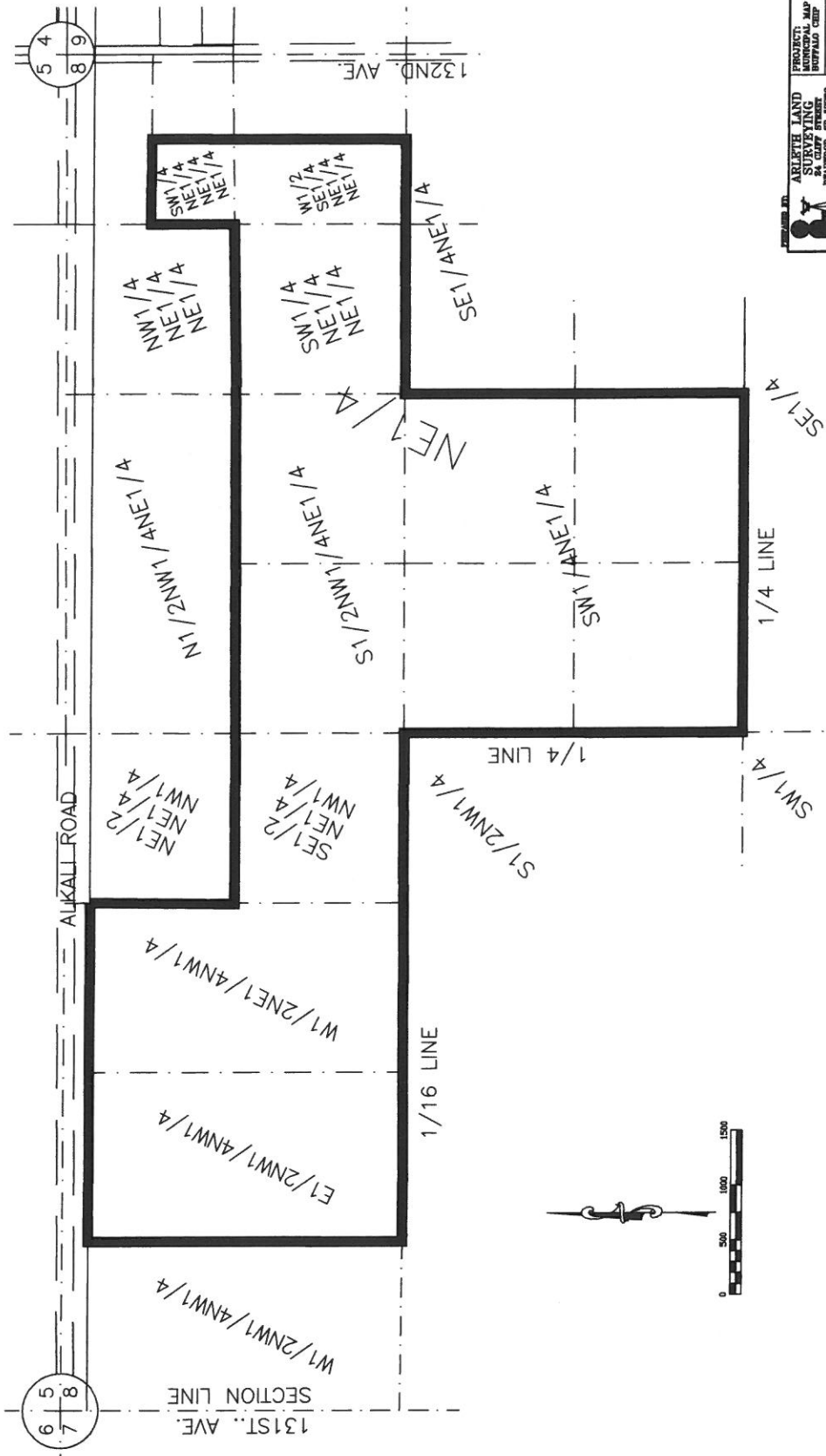
